Alberta Stallion Stakes Futurity - sustaining payment required June 1 - \$300 Nomination Form available on website.

Alberta Stallion Stakes Derby - \$250 sustaining payment required June 1. Nomination Form available on website.

Canada QH Cup Futurity - \$300 sustaining payment required June 1 for horses that went through 2024 CC Sale, \$600 for non Sale horses. Nomination Form available on website.

Canada QH Cup Derby - \$200 sustaining payment required June 1 for Futurity nominated horses, \$250 for non Futurity horses. Nomination Form available on website.

REMEMBER: 2025 membership forms and fees must be received with nominations. It is the Owner's responsibility to ensure that all payments are in accordance with AQHRA terms and conditions and received on time at the AQHRA office. No exceptions will be made regarding waiving of late penalties. Time of Entry payments are due in the Race Office to the HBPA Bookkeeper on or before deadline, no grace period given.
