### Incentive to Consign/Purchase

There is a \$35,000 added money Sale Stakes to be run in 2027 for eligible yearlings that pass through the sale's ring of the 2026 Annual AQHRA Canada QH Cup Sale.

#### Generation of Berths for 2027 Canada QH Cup Futurity

- i. Yearling which passes through the sale ring receives a non-transferable berth to both the Canada Cup Futurity and the Sales Stakes Futurity.
- ii. Consignor of yearling which sells through the sales ring receives an open berth for the Canada Cup Futurity.
- iii. Purchaser of yearling which sells through the sales ring receives an open berth for the Canada Cup Futurity.

\*Open berths revert back to the association after February 1<sup>st</sup> 2027. They will then be available for purchase for \$300 on a first come, first paid basis. Monies collected from these reverted AQHRA berths will go into the AQHRA general funds.\*

## CONSIGNOR'S CONTRACT: PLEASE READ BEFORE SIGNING

I hereby consign the following livestock (the "Animals") to Alberta Quarter Horse Racing Association ("AQHRA") for sale in the 2026 Annual AQHRA Canada QH Cup Sale (the "Sale") and inclusion in the sale catalogue to the following terms and conditions:

1. I warrant the title to each Animal free from all adverse claims to ownership. I authorize AQHRA to advertise and sell each Animal at public auction to deliver possession of each Animal to the highest recognized bidder, to transfer title to highest recognized bidder and to receive and disburse the proceeds of sale for my account. The starting/upset bid for yearlings is \$1000 and all other horses is \$500.
2. I agree to pay the set consignment fees to AQHRA by the required dates and am a current AQHRA member. I acknowledge that there is no refund of fees after any consignment deadline if I were to withdraw my horse from the sale. I agree to pay AQHRA **the \$100 plus 3% commission on each Animal sold computed on the final recognized bid at the Sale or the \$100 plus 3% commission** on the final recognized bid at the Sale if the horse is not sold (repurchases/pass outs/buybacks).
3. **AQHRA, Auctioneers and employees act as agents for the consignors and assume no liability for either purchasers or consignors.** The consignor agrees to guarantee the horse to be sound and as represented. Any horse whose condition is as aforesaid and is not so announced at the time of sale, said entry will be subject to return to consignor at the discretion of the purchaser with refund of purchase price, provided that the consignor and AQHRA are notified in writing by the purchaser with veterinarian certificate attached, stating the defect, within twenty-four (24) hours of conclusion of the sale in which the horse(s) is purchased. In case of return, consignor shall pay all proper expenses incurred in the horse from the time of sale until return to the consignor. All warranties set forth in this agreement shall terminate no later than twenty-four (24) hours from the conclusion of the sale in which the horse(s) is purchased, after which purchaser shall have no right of return of any horse for any reason whatsoever.
4. Current sales tax will be added to the final purchase price on all Animals sold through this auction. All GST derived from this auction will be paid to Consignors for submittal to Revenue Canada.
5. **I will deliver a signed AQHA transfer report, the original parentage verified AQHA registration certificate and negative coggins at time of sale.**
6. **I agree to deliver the Animal to the Sale Location no later than NOON on the day of the Sale.** I understand that I am required to care for each Animal while it is stabled on the Sale premises. Horses from out of province must have appropriate manifests. Horses must leave the Sale Location before 10 A.M on Wednesday, September 23th, 2026.
7. *Unless otherwise announced, there is no representation or warranty as to the pregnancy or breeding status of any horse. Each broodmare or broodmare prospect in this sale will be offered with a veterinary certificate provided by consignor from a licensed veterinarian setting forth the pregnancy and breeding status of the mare in the opinion of the examining veterinarian based on their examination done within thirty (30) days of the sale.*
8. I understand that to protect my desired sales price for the Animal(s), I must (A) be the final bidder on the Animal or (B) deliver a AQHRA Reserve Bid Form to AQHRA sale representative before the start of the Sale.
9. No registration papers will be released until the \$100 plus 3% commission has been paid.
10. I understand that the AQHRA will use reasonable efforts to verify the financial responsibility of the buyer of each Animal and that possession of each Animal sold will be given to the buyer against receipt of payment after satisfaction of AQHRA's settlement procedures. I agree that if the sale of any

Animal is not consummated by reason of default of the buyer or otherwise, AQHRA will not be liable for the purchase price of the Animal. The AQHRA will attempt to assist in the collection of the purchase price of the Animal, in the recovery of the Animal, or in the resale of the Animal by private treaty in the event that I might request assistance.

11. Payments to consignors will be done as follows:
  - a. Payments to AQHRA consignors will commence 21 days after the Sale.
  - b. Registration Certificates will not be transferred until the Buyer's check has cleared the bank.
  - c. Consignors' checks will be held until AQHRA has all necessary papers in AQHRA office.
12. Payments must be made in full at the end of the Sale, purchaser is to pay sale cashier. Horses must be removed from the sales ground before 10 am, Wednesday, September 23rd, 2026.
13. I understand and agree that the terms of the Sale Conditions and Settlement Procedures published in the Sale Catalog will govern the sale of each Animal and I agree to be bound thereby.
14. Generation of berths through the Sale for the 2027 Canada QH Cup Futurity
  - a. Yearling which passes through the sale ring receives a non-transferable berth to both the Canada Cup Futurity and the Canada Cup Sales Stakes.
  - b. Consignor of yearling which sells through the sales ring receives an open berth for the Canada Cup Futurity.
  - c. Purchaser of yearling which sells through the sales ring receives an open berth for the Canada Cup Futurity.
15. **Open berths generated from this Sale will revert back to the AQHRA after February 1<sup>st</sup>, 2027. They will be available for purchase for \$300 on a first come, first paid basis. Monies collected from these reverted AQHRA berths will go into AQHRA General Funds.**
16. **There is a \$35,000 added money Sale Stakes to be run in 2027 for eligible yearlings that pass through the sale's ring of the 2026 Annual AQHRA Canada QH Cup Sale.**
17. **There will be \$1,000 bonus for each of the top five (5) fastest sale graduates of the 2026 Canada QH Cup Sale that compete in the 2027 Canada QH Cup Futurity Trials.**

### IMPORTANT THINGS TO REMEMBER

- The Entry Fee for the 2027 Canada QH Cup Futurity is \$1000 for a Sale Horse and \$2000 for a non-sale horse (requires a berth). The payment schedule begins with nominations due on February 1<sup>st</sup>, 2027: \$200 sale horse / \$400 non-sale horse.
- A Late payment structure will be offered in 2027.
- All persons attending this sale do so at their own risk.
